New Orleans Terminal, LLC Trucker Safety Rules

New Orleans Terminal – Trucker Rules & Safety Guidelines

New Orleans Terminal is committed to maintaining a safe and efficient environment for all individuals conducting business on terminal grounds, including truck drivers, visitors, and staff. The following rules are in place to ensure safety and operational efficiency:

1. **TWIC Requirement** – All persons entering the terminal must carry a valid TWIC card or be accompanied by an authorized escort.
2. **Passengers** – Passengers are not permitted in OTR trucks unless pre-approved by terminal management. Requests must be submitted in writing prior to arrival.
3. **Personal Protective Equipment (PPE)** – Proper PPE is required when exiting your vehicle on terminal grounds, including safety vest, steel-toe shoes, and hard hat (requirements may vary by operation). Flip-flops are strictly prohibited.
4. **Cell Phone Use** – Cell phones, earpieces, and headphones are prohibited while operating a vehicle on terminal grounds. If cell phone use is necessary, pull over and park in a safe area away from operations.
5. **Stop Signs** – All stop signs must be obeyed. They are in place for your safety and ours.
6. **Speed Limits** – 15 MPH in the yard; 5 MPH in warehouses and chassis roadways. Obey all posted limits.
7. **Restricted Areas** – Do not cut through the Napoleon C warehouse or Napoleon C pit. These are active pedestrian work areas. Violations may result in a 3-day suspension.
8. **Traffic Flow** – Driving against the flow of traffic is prohibited. Observe all traffic control devices. Most OTR traffic roadways are one-way.
9. **Truck Identification** – OTR trucks must be clearly marked with the truck number (UTN) on both sides and on top of the cab/hood.
10. **Driver Conduct in Yard** – Remain inside your truck while in the main yard. Do not walk around or between containers.

11. **Driving Restrictions** – Do not cut through stacks or yard sections. U-turns in yard sections are strictly prohibited.
12. **Seatbelts** – Must be worn at all times when operating a vehicle on terminal grounds.
13. **RTG Safety** – Stay within designated RTG lanes and do not park on red lines.
14. **Littering** – Dispose of trash in proper receptacles. Littering is prohibited.
15. **Smoking** – Permitted only in designated smoking areas.
16. **Pin Procedures** – Drivers must unlock pins under the second inbound canopy/pedestal. Pins are to be locked only at the outbound lane.
17. **Inspection Areas** – Do not cut across safety zones in inspection areas. Violations may result in a 3-day suspension.
18. **Questions or Concerns** – Call (504) 648-6220 for assistance.
19. **Security Compliance** – All drivers must comply with the instructions of Security Guards while on terminal grounds. Violations may result in a 3-day suspension.
20. **Sanitation** – For health, safety, and respect for all, please use the designated portalet facilities. Public urination is strictly prohibited and may result in disciplinary action.

Enforcement

Anyone found in violation of these rules will be subject to suspension (applicable to both terminals).
